

Exhibitor Agreement

By submitting an Exhibitor Contract, you are agreeing to the following mandates, rules, and liabilities during the 2021 MBC Annual Meeting.

Unoccupied Space

The exhibits coordinator reserves the right, should any exhibit space remain unoccupied or forfeited due to failure of the exhibitor to make full payment, to rent the space to another exhibitor or use the space for any purpose. The exhibitor shall remain responsible for payment of all expenses due for equipment, furnishings, and services requested or specified in the exhibitor contract if the space is not subsequently rented. No refunds after October 1, 2021.

Display Materials Rules

No display materials may be attached to the drapery or its framework. Exhibit materials may not extend beyond the assigned space, extend into the aisles, or block the visibility of other exhibits. All boxes are to be kept under the skirting. Exhibits are to reflect the work, purpose, and goals of the agency or group assigned the exhibit space.

Facility Liability

Exhibitor shall be fully responsible to pay for any and all damages to property owned by the Convention host facility, its owners or managers which results from any act or omission of Exhibitor. Exhibitor agrees to defend, indemnify and hold harmless the Convention host facility and each of its respective affiliates and their officers, directors, partners, agents, members, managers and employees (collectively, the "Convention host facility indemnified parties") from and against any and all demands, claims damages to persons or property, losses and liabilities, including reasonable attorneys' fees (collectively "Claims") arising out of or caused by the Exhibitors or its members', agent's, employees', independent contractors' negligence in connection with the use of Convention host facility property, except to the extent and percentage attributable to the negligence of the Convention host facility indemnified parties.

Exhibitor's liability shall include all losses, costs, damages or expenses arising from or out of or by reason of any accident or boldly injury or other occurrences to any person or persons, including the Exhibitor, its agents, employees, and business invitees which arise from or out of Exhibitor's occupancy and/or use of the exhibition premises, the Convention host facility or any part thereof. The Exhibitor understand that the Convention host facility does not maintain insurance covering the Exhibitor's property and that it is the sole responsibility of the Exhibitor to obtain such insurance.

Convention Liability

An exhibitor will make no claim against the Missouri Baptist Convention, the MBC annual meeting, the host facility or participating contractors for damage, destruction of property, theft, loss, or injury to himself or his employees. No claim shall be made for damage of any nature or character, including damage by reason of failure of the Missouri Baptist Convention to provide exhibit space, exclusion of exhibits or exhibitors, or failure to hold the meeting as scheduled.

The exhibitor assumes the entire responsibility and liability for losses, damages, and claims arising out of exhibitor's activities at the host facility and/or Convention host facility premises and will indemnify, defend and hold harmless the host facility and/or Convention host facility, its agents, servants and employees from any and all such losses, damages and claims.

Property Damage

An exhibitor is liable for any damage he may cause to, and may not attach signs, apply paint, adhesive or any other material to building walls, floors, ceilings, columns, furnishings, and equipment of the host facility, or rental furnishings and equipment.

Fire, Safety and Health

An exhibitor accepts responsibility for compliance with all applicable fire, health, and safety requirements regarding the installation and operation of exhibits in the host facility. Safety equipment must be used as necessary to prevent injury to spectators and exhibitors. Only fireproof materials may be used.
