### **Resolutions recommended for adoption**

The Committee on Resolutions recommends that the messengers to the annual meeting adopt the following resolutions:

## Resolution No. 1: Courtesy Resolution to Express Appreciation

WHEREAS, the officers, committees, and staff of the Executive Board of the Missouri Baptist Convention have, through their preparation, labor, and spirit, contributed to a successful convention;

WHEREAS, the members of the Local Arrangements Committee along with Director of Missions and staff of the Blue River-Kansas City Baptist Association, have made every effort to make our stay in this area comfortable;

WHEREAS, Sheraton Hotel has assisted with preparations and have made their excellent facilities and competent staff available in hosting this meeting; be it

RESOLVED, that we, the messengers to the 179th Annual Session of the Missouri Baptist Convention

## **Resolution No. 2:**

## On the U.S. Supreme Court Ruling Striking Down the Defense of Marriage Act (DOMA)

WHEREAS, The Defense of Marriage Act of 1996 was passed with overwhelming majorities in the 104th Congress (House: 442-67, Senate: 85-14); and was signed into law by President William J. Clinton on September 21, 1996 and has been federal law for over 16 years; and

WHEREAS, Southern Baptists have on multiple occasions (1996, 2003, 2008, 2011) affirmed through resolutions the truth and principles that the Defense of Marriage Act seeks to defend; and

WHEREAS, the federal government has an appropriate role in preserving the foundations of a healthy society; and

WHEREAS, redefining the concept and legality of marriage to mean anything other than the union between one man and one woman would fundamentally undermine the historic and biblical foundation of a healthy society (Genesis 1:28, 2:24, Matthew 19:4-6); and

WHEREAS, equating same-sex marriage relationships with heterosexual marriage creates a host of

religious liberty and freedom of conscience conflicts; and

WHEREAS, the U.S. Supreme Court has ruled that the Defense of Marriage Act is unconstitutional and that same-sex couples who are legally married will be entitled to equal treatment under federal law; and

WHEREAS, the U.S. Supreme Court has eroded the stability of the institution of marriage by ruling that part of the Defense of Marriage Act is unconstitutional and that same-sex couples who are legally married will be entitled to equal treatment under certain federal laws; therefore be it

RESOLVED, that the messengers to the Missouri Baptist Convention meeting in Kansas City, October 28-30, 2013, express our continued opposition to and grave disappointment in the ruling of the U.S. Supreme Court to strike down the Defense of Marriage Act; and be it further

RESOLVED, that we reaffirm our historic and consistent support of the biblical definition of marriage as the exclusive union between one man and one woman; and be it further

RESOLVED, that we encourage the churches of the Missouri Baptist Convention to make their marriage convictions clear in their confessions of faith and adjust their wedding policies accordingly; and be it further

RESOLVED, that we encourage pastors to speak strongly, prophetically, and redemptively concerning the sinful nature of homosexual behavior, the urgent need to protect biblical marriage, and the certainty that the blood of Christ can atone for any sin; and be it finally

RESOLVED, that we encourage the churches of the Missouri Baptist Convention to continue to lovingly reach out evangelistically, declaring our love in Christ for all people regardless of their perceived sexual identity and/or sexual orientation, praying that God will bring all into a saving knowledge of our Lord Jesus Christ.

## Resolution No. 3:

## On the Change in Membership Policy of the Boy Scouts of America

WHEREAS, the Scout Oath contains language that is consistent with belief in God and biblical precepts that serve as the basis for Christian faith: "On my honor, I will do my best to do my duty to God and my country and to obey the Scout Law; to help other people at all times; to keep myself physically strong, mentally awake and morally straight;" and

WHEREAS, the Scout Oath contains language that serves as the basis for Christian faith and throughout its history has restricted from membership and leadership those persons who would affect the group's ability to advocate their own viewpoints of God and His moral precepts; and

WHEREAS, the Boy Scouts of America has been providing a program for young men that builds character and trains them in personal responsibilities of participating citizenship, knowing that helping youth is a key to building a more conscientious, responsible, and productive society; and

WHEREAS, many Missouri Baptist churches sponsor a Boy Scout troop or are involved in Scouting; and

WHEREAS, The Baptist Faith and Message 2000 states that "Christians should oppose all forms of sexual immorality, including adultery, homosexuality, and pornography," and have expressed strong opposition to the normalization of sinful behavior in American culture through resolutions over the past thirty years; now, therefore, be it

RESOLVED, that the messengers to the Missouri Baptist Convention Annual Meeting on October 28 – 30th 2013, express our continued opposition to, and disappointment in, the decision of the Boy Scouts of America to change its membership policy to allow openly homosexual members; and be it further

RESOLVED, that we express our gratitude to, and continued prayer for, those Council Members who

voted in opposition to the policy change for membership; and be it further

RESOLVED, that we affirm the right of all families and churches to prayerfully review their relationship with the Boy Scouts of America, expressing our support for those churches and families that as a matter of conscience can no longer be part of the Scouting family; and be it further

RÉSOLVED, that we encourage churches and families that remain in the Boy Scouts to seek to impact as many boys as possible with the life-changing Gospel of Jesus Christ, to work toward the reversal of this new membership policy, and to advocate against any future change in leadership and membership policy that normalizes conduct opposed to the biblical standard; and be it further

RESOLVED, that we encourage churches that choose to sever ties with the Boy Scouts not to abandon their ministry to boys but consider implementing or expanding a Royal Ambassadors ministry, a distinctively Southern Baptist missions organization to develop godly young men; and be it finally resolved

RESOLVED, that we declare our love in Christ for all people regardless of their perceived sexual orientation or identity, praying that God will bring all into a saving knowledge of our Lord Jesus Christ.

## Resolution No. 4: On 50/50 Cooperative Program Support

WHEREAS, the 2014 Missouri Baptist Convention budget calls for a 60/40 sharing of Cooperative Program funds received between the Missouri Baptist Convention and the Southern Baptist Convention, and

WHEREAS, the Missouri Baptist Convention Executive Director, Dr. John Yeats and the Missouri Baptist Convention Executive Board have made a commitment to lead the Missouri Baptist Convention to a 50/50 sharing of the Cooperative Program funds with the Southern Baptist Convention by 2020; be it

RESOLVED, that we, the messengers to the 179th

Annual Session of the Missouri Baptist Convention meeting in Kansas City, Missouri, October 28-30, 2013, encourage Missouri Baptist Convention churches to continue supporting the Cooperative Program and give serious consideration to increasing their commitment to the Cooperative Program by 2020.


