We are never alone, Yeats tell messengers

Followers of Jesus are never alone, Dr. John Yeats, MBC executive director, told messengers Monday evening at the 182nd Annual Meeting of Missouri Baptists.

Yeats spoke to Missouri Baptists in his president's address during the opening session of the meeting, held in the St. Charles Convention Center.

"The Lord Jesus said to His followers, 'I am with you always, to the end of the age,'" noted Yeats. "And in Hebrews 13 He reminded us, 'I will never leave you or forsake you."

Even so, there are trying times when believers find themselves anxious. That's why it's so important for Christians to belong to a team, according to Yeats. "I did not say be on a team, because you can be on someone's team and be alone. But when we belong to a team, aloneness tends to evaporate."

Yeats said there are several types of teams to which Christians may belong, from sports teams to marriage to the local church. But two important teams we often overlook are the Missouri Baptist Convention and the Southern Baptist Convention, where local churches cooperate voluntarily to accomplish more together than any local church could accomplish alone.

The executive director encouraged Missouri

Baptists to work toward forming gospel teams that feature a number of key personal qualities.

First, humility. "Of all the character traits that contrast the world and the gospel, humility is the greatest," he said. "Humility is not thinking less of yourself as much as it is thinking less about self."

Second, holiness. The apostle Peter urged followers of Jesus to serve as obedient children, becoming like the Holy One who called them. "The enemies of the gospel want us to morally fail," cautioned Yeats. "Don't be duped into thinking you are above temptation. Stay spiritually on point in the Word of God."

Third, hunger for the mission—"the gospel mission of transforming lives and communities with the gospel," said Yeats. "We want to see the people of God compassionately share their convictions in the workplace, the school house, and the state house."

Fourth, faithfulness. Wherever God places people on His team, it's important to acknowledge His calling and to be faithful in whatever He calls us to do, said Yeats. "That's part of what the Cooperative Program is all about," he said. "It is our working together to support one another in these days before the Lord cracks open the skies. Be faithful here and now."

Fifth, hear the Master speak. John 10:27 is a precious promise, Yeats noted. As believers, we hear the voice of the Lord and are assured we belong to Him. "We are on mission to follow the Master in all things," he said "When we hear His voice through the Word or through the Holy Spirit, it is imperative that we obey him."

Yeats closed with a word of encouragement: "Because of the Lord's death on the cross, the battle is won. Loneliness is a defeated foe. Now act like it—be strong and courageous. Let our character reveal the magnificent work of grace begun in us for the purpose of shaping the course of history for generations to come."

Additions to Executive Board report

During the Monday afternoon meeting of the Executive Board the following items were reported for inclusion in the Executive Board report.

Report from the Executive Board to the Missouri Baptist Convention

(To be added to the Executive Board Report on page 55 of the *Book of Reports*.)

- 1. The Board considered and approved three recommendations from the Administrative Committee.
- 2. The Board heard and adopted the report and plan of action of the Agency Restoration Group.

Additions to Executive Board Recommendations

(To be added to the Executive Board Recommendations on pages 57-61 of the *Book of Reports.*)

8. On request by the Missouri Baptist Foundation Board of Trustees, the Executive Board recommends that the following amendments to the 1994 Charter of the Missouri Baptist Foundation be approved by the Messengers to the 2016 Annual Meeting of the Missouri Baptist Convention:

1. That Article IV be amended by the addition of the following sections:

(H) This Corporation is an entity of the Missouri Baptist Convention ("MBC") and agrees that MBF is subject to the governing documents of the MBC, as amended from time to time, including the *Baptist Faith & Message*, current edition. MBF Trustees have a fiduciary relationship to the Corporation and to the MBC.

(I) The MBC is the sole member of the MBF Corporation and as such the MBC has in its sole and absolute discretion the following rights of membership:

- 1. the sole and exclusive right to elect and remove Trustees of the MBF;
- 2. the right to notice of all meetings of the MBF's Board of Trustees;
- the right to recommend, approve, or reject, in writing, any addition, deletion or other amendment to the MBF's Charter and Bylaws;
- the right to approve or reject the sale, mortgage, lease, pledge or transfer of all or substantially all of the MBF's assets;
- 5. the right to approve or reject the creation, amendment or dissolution of any subsidiary of the MBF;
- 6. the right to be present by an officer at all

meetings of the MBF's Board of Trustees;

- 7. the right to have the MBC president and MBC Executive Director serve as *ex officio* Trustees, without vote, of the MBF's board;
- the right to have the MBC Executive Director serve as a non-voting member of any search committee for MBF's Chief Executive Officer; and
- the right to approve or reject any material change of the ministry or purpose statement of the MBF.
- (J) Nothing in the Charter or Bylaws of the Corporation requires the Missouri Baptist Foundation, its trustees, officers or agents to follow any civil law, rule or ruling that requires any act or omission that violates Scripture or any religious belief or practice based on Scripture, compatible with the *Baptist Faith & Message*, current edition, or that violates the right of Religious Freedom and Free Exercise which God has granted to all people and which the First Amendment to the U.S. Constitution was intended to protect.

2. That Article VIII be amended by the addition of the following sentence:

This Charter, including this Article VIII, the Consent Clause, cannot be deleted or amended by Trustees without approval in writing by the MBC Messengers at an Annual Meeting, the "in writing" requirement being satisfied when the MBC records the result of the Messenger vote.

3. That Article IX be amended by the addition of the following sentence:

A Bylaw amendment, like a Charter amendment, must also be approved in writing by the MBC Messengers, after recommendation by the Executive Board.

9. That the Executive Board recommends that the Convention adopt the following Special Order regarding the proposed amendments to the MBC Governing Documents ("Proposed Amendments"). If passed by a two-thirds vote, the Special Order will govern all further MBC procedure for voting on the Proposed Amendments.

SPECIAL ORDER OF BUSINESS FOR AMENDING GOVERNING DOCUMENTS MISSOURI BAPTIST CONVENTION

 The Proposed Amendments are presented by recommendation from the Executive Board during the 2016 annual meeting, includ-

- ing any edits printed in the *Daily Bulletin* approved by MBC legal counsel, thus fulfilling all advance Notice requirements.
- The Proposed Amendments require no action by the 2016 Convention, other than the Chairman announcing they are introduced, received and stand referred to the Committee on Continuing Review (CCR) until the 2017 Annual Meeting.
- 3. Any motion related to the Proposed Amendments made by a messenger during the 2016 annual meeting also stands referred to the CCR until the 2017 annual meeting.
- 4. Discussion or questions about the Report on the Proposed Amendments at the 2016 annual meeting may be limited to the time fixed by the Order of Business Committee, unless 2/3 of the messengers vote to extend the time.
- After the 2016 annual meeting concludes, CCR must complete its review of the Proposed Amendments and any referred motions by July 1, 2017.
- 6. On or before September 1, 2017, MBC legal counsel in consultation with CCR may direct that certain edits be made in the Proposed Amendments as are necessary to correct

- spelling, grammar, consistency, or other legal purpose, so long as the edits do not substantially change the meaning of a material provision, which edited version must be printed in the Pathway and posted online at MoBaptist. org by that date. These steps substantially satisfy all advance notice requirements contained in any current governing document.
- 7. At the 2017 annual meeting during the time scheduled by the Order of Business Committee, the Messengers will vote on the Proposed Amendments, with edits by legal counsel, without further amendment from the floor. The vote may be taken as to all documents jointly since the amended documents are inter-dependent.
- 8. Any motions offered during the 2017 annual meeting by a messenger to amend the Proposed Amendments will stand referred to the proper reviewing authority until the 2018 annual meeting. If the Proposed Amendments are adopted, the proper reviewing authority will be the Executive Board. Any motion by a messenger that would prevent or postpone an "up or down" vote on the Proposed Amendments at the 2017 annual meeting will be ruled out of order.


Franks appoints tellers for 2016 meeting
